TERMS & CONDITIONS

1. This is open to all business Customers who have a Credit Agreement with Tradelink or one of its associated entities. Participation in this is deemed acceptance of these Terms & Conditions.
2. This applies exclusively to the following drain cameras, drain cleaner and drain jetter machines purchased from Tradelink:
 - a. Ridgid Cameras
 - b. Ridgid Drain Cleaners
 - c. Ridgid Drain Cleaning Jetter Machines

Tradelink and the Customer agree that:

3. The cost of the Tools purchased during the may be paid in six equal monthly instalments. The minimum monthly instalment will be equal to the invoiced cost of the Tools divided by six. Instalment payments greater than the monthly minimum can be made by prior arrangement with Tradelink. The first instalment will be due one month after the purchase date with the final instalment due six months after the purchase date.
4. Goods purchased pursuant to this CANNOT be returned unless the goods are faulty. If the goods are faulty, the seller may, at its discretion, choose to replace the goods or provide a credit equal to the value of the purchase.
5. If the Customer fails to pay a monthly instalment as and when due, the full purchase price for the Tools will immediately fall due and interest calculated at 8% per annum will be payable from the date of default to the date that full payment is made.
6. This cannot be used in conjunction with any other offer which may be available.
7. The Customer warrants that:
 - a. the purchase of the Tools is wholly or predominantly for business purposes;
 - b. the Tools are not being acquired for the purpose of re-sale by the Customer and will not be re-sold by the Customer; and
 - c. the person accepting these Terms and Conditions on the Customer's behalf has full power and capacity to do so.

8. It is a further condition that the Customer's Credit Agreement, and the standard terms and conditions of the seller or its associated entity (as the case may be), continue to apply to the Customer in relation to the supply of the Tools save where they conflict with these terms, in which case these terms prevail.

Tradelink, its suppliers and any of their contractors and agents shall not be liable for any loss, damage, personal injury or death whatsoever which is suffered (including, but not limited to, direct, indirect or consequential losses) or for personal injury which is suffered or sustained by any other person or otherwise suffered or sustained in connection with participating in this transaction, as a result of buying or making use of the Tools, or any act or omission (whether negligent or not) of Tradelink or its suppliers, contractors or agents or any person associated with any of them, except for any liability which cannot be excluded by law.
